Whereas, By Resolution 93 of 2017, the County of Jefferson approved the above project by making a commitment for the cost of the Preliminary Engineering and Right of Way Incidental phases of the project, and authorizing \$177,000 to cover the cost of these phases, and

Whereas, The County has allocated \$500,000 additionally to this project through the Adopted 2018 Budget for a total of \$677,000, and

Whereas, The County of Jefferson desires to advance the Project by making a commitment of 100% of the federal and non-federal share of the cost of the Final Design, Construction and Construction Inspection phases of the project, and

Whereas, The total project cost is projected by NYSDOT at \$2,230,000.
