Chairman Reed introduced a resolution Authorizing Agreement and Amending the 2019 County Budget in Relation to the FY19 State Homeland Security Program (SHSP) Grant and entertained a motion for consideration. A motion was duly made by Legislator Ferris and seconded by Legislator Maxon. There being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Reed introduced a resolution Amending the 2019 County Budget to Recognize Insurance Recovery within the Road Machinery Fund and entertained a motion for consideration. A motion was duly made by Legislator Cantwell and seconded by Legislator Doldo. There being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Reed introduced a resolution Authorizing an Undertaking on File with the New York State Department of Transportation and entertained a motion for consideration. A motion was duly made by Legislator Jareo and seconded by Legislator Doldo. In response to a question from Legislator Maxon, Mr. Hagemann stated that there has been updates to the previous agreement resulting in this new resolution. There being no further discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Reed introduced a resolution Authorizing Agreements in Relation to Juvenile Secure Detention and the Supervision & Treatment Services for Juveniles Program (STSJP) and entertained a motion for consideration. A motion was duly made by Legislator Doldo and seconded by Legislator Maxon. There being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Reed introduced a resolution Recognizing NYS Governor's Traffic Safety Committee Police Traffic Services Program Grant and Amending the 2019 County Budget in Relation Thereto and entertained a motion for consideration. A motion was duly made by Legislator Cantwell and seconded by Legislator Doldo. Legislator Jareo expressed his displeasure with Albany's encouragement to have our local police departments inflict financial hardships on our

constituents for meaningless, victimless crimes that are for invasive laws. There being no further discussion, the Committee agreed to sponsor the resolution as presented, except Legislators Jareo and Maxon.

There being no further business, on a motion by Legislator Jareo seconded by Legislator Maxon and unanimously carried, the meeting adjourned at 6:05 p.m.
