Whereas, The United States Department of the Army is desirous of establishing a fourth Army Corps Headquarters in the very near future to help fulfill its National Defense Strategy, and

Whereas, The location of this new Army Headquarters is yet to be determined but will be assigned to one of 31 military installations within the Continental United States, and

Whereas, This new Army Headquarters will maintain a rotating operational command post of approximately 200 soldiers overseas with approximately 630 soldiers being trained at headquarters to maximize flexibility to always support other combatant commands wherever needed, and

Whereas, Fort Drum, which is home to the United States Army's most deployed division in the 10th Mountain Light Infantry Division, is ideally suited to become the home base for the soon to be established fourth Army Corps Headquarters, and

Whereas, Jefferson County and the entire "North Country" region has a long history of supporting and integrating Fort Drum with a community approach for quality education, state of the art health care services, easily accessible airport accommodations, a wide variety of newly constructed housing units, vast recreational opportunities and welcoming the members of the Army and their families as friends and neighbors.

Now, Therefore Be It Resolved, That the Jefferson County Board of Legislators enthusiastically endorses the future stationing of the Fourth Army Corps Headquarters at Fort Drum, New York, and be it further

Resolved, That Jefferson County stands ready to lend its continuing support to this important initiative for both Fort Drum and for the improved defense of our nation, and is confident that activation and stationing of the U.S. Army's Fourth Corps Headquarters can be accomplished by the desired October 2020 time frame, and be it further

Resolved, That certified copies of this resolution be sent to the U.S. Department of the Army, Senators Charles Schumer and Kirsten Gillibrand, Congresswoman Elise Stefanik, Governor Andrew Cuomo, Senator Patty Ritchie, Assemblymen Ken Blankenbush, Mark Walczyk and Will Barclay.

Seconded by Legislator: Patrick R. Jareo

All members present voted aye.

With regard to the recently attended NYSAC Conference, Legislator Montigelli advised that other counties were all concerned about the same kinds of things we are; the State Budget, Medicaid, criminal justice reforms, indigent defense, and he did not see any State Legislators in

attendance. He said Dave Lucas, Director of Finance and Intergovernmental Relations for NYSAC did a very informative State Budget review presentation and legislators can find it online if they are interested. Chairman Gray added that the State wants to make counties responsible for more of the costs associated with Medicaid but there doesn't seem to be one agreed upon way of doing that. He said they are possibly looking to put a soft cap on Medicaid at 3%; anything over 3% growth (in programming and/or admin) may become the responsibility of the county, and if we exceed the tax cap any growth at all in Medicaid spending may become the county's responsibility. He said counties don't have any programming cost controls, or any voice at the table, we only administer the program for the State. Administrator Hagemann noted the one positive was that Comptroller DiNapoli acknowledged that the 4 billion deficit for Medicaid was not caused by counties.

Chairman Gray asked if any legislators were interested in imposing the 5¢ per paper bag fee after March 1st when plastic bags are no longer legal to use in certain instances. He advised that he told the media it was not on our radar but said he would entertain whatever legislators want to do, cautioning that we would essentially be collecting money as an agent for New York State as 60% of it would go back to the State. No legislators expressed interest in moving forward with the fee.

Administrator Hagemann reminded legislators that April 1st is Census Day and urged them to network with anyone they come in contact with to fill out and complete their census information, it is crucial that everyone is counted. He said there is a concern that with a population shift there may be the loss of a Congressional seat. The time frame for the census is early to mid March - July.

There being no further business of the Board, on a motion by Legislator Maxon seconded by Legislator Ferris and unanimously carried, the meeting was adjourned at 6:25 p.m.
