Authorizing Use of Capital Chargebacks to Match State Aid in Relation to the Jefferson Community College Green Campus Entryway Project

Whereas, By Resolution 87 of 2019, this Board of Legislators authorized Capital Chargeback funding of \$497,000 towards JCC's Green Campus Entryway Project (Project) for a total cost of \$1,377,000, and
Whereas, The Project is also being funded by a NYS EFC Green Innovation Grant of \$880,000 and was not expected to include SUNY funding, thus was not established as a capital account in the County budget, and
Whereas, The Project had to be re-bid this spring and construction costs increased since 2019 with a revised expected total cost of \$1,504,177, and
Whereas, By Resolution 145 this Board authorized the use of \$97,639 of the Capital Chargebacks committeed in Resolution 87 of 2019 as local match to state funding of \$97,639, and
Whereas, New York State has previous funding from SUNY 1998 advance for JCC capital projects of which \$29,538 remains available, and
Whereas, JCC wishes to designate an additional \$29,538 of the Capital Chargebacks committed in Resolution 87 of 2019 to provide the local match for the additional state funding of \$29,538, and
Whereas, The JCC Faculty Student Association has committed to cover any gap in funding the Project between the EFC \$880,000, SUNY \$127,177 and Capital Chargebacks \$497,000.

Whereas, A Notice of Claim entitled "Kali Waite v. County of Jefferson", has been filed pursuant to General Municipal Law alleging personal injury and property damage resulting from an automobile accident with a County Sheriff's vehicle; and

Whereas, On the advice of counsel after the consideration of the documentary evidence and legal basis relating to the claim, and that a negotiated settlement is, as a matter of litigation analysis and risk management, a cost-effective alternative to full trial of the action. Counsel has advised that the range of possible verdicts includes the possibility of a verdict of "no cause for action," but also may include an adverse verdict in an amount which is in the discretion of the jury and which exceeds the settlement demand of the plaintiff; and that the substantial costs of proceeding to trial—including both the labor and opportunity costs of making senior employees of the County available throughout the trial; the costs of attorney preparation and presentation of trial; and the costs to be incurred for our expert witnesses in preparing for and testifying at trial serve to offset the total cost of settlement to the County; at the same time that a settlement defines the extent of expense and removes the threat of uncapped exposure.

Whereas, Pursuant to Local Law No. 5 of 1986, a settlement or comprise of a claim in the amount of more than \$10,000.00 requires the approval of the Board of Legislators,

Now, Therefore, Be It Resolved, That for purposes of avoiding the costs and expense of a trial; and for purposes of compromising a claim at a point well within the estimated range of possible jury verdicts, the Board of Legislators does hereby agree to a settlement of the matter herein; and the sum of Twenty Thousand Dollars (\$20,000.00), be and hereby is appropriated from Account: 45193000 04600, the Judgment and Claims Fund, for purposes of settling the referenced litigation against the County of Jefferson; and the County Attorney is hereby authorized to tender that sum to counsel for the plaintiff, upon such terms and conditions as counsel agree, upon receipt of a Release of all claims in a form acceptable to the County Attorney and receipt of a fully executed Stipulation of Discontinuance.
