POLICY:

Jefferson County is committed to maintaining a safe work environment to protect its employees, the public, County equipment and facilities. The County maintains a comprehensive safety program and works to prevent injury and damage, as well as to reduce potential liability.

The Safety Officer will be responsible for developing and maintaining the safety program, under direction of the Human Resources Director. County Department heads will have the primary responsibility for implementing the program.

GUIDELINES:

- 1. The County Safety Officer will be responsible for developing, distributing and periodically updating a comprehensive safety manual and an abbreviated employee safety handbook, under direction of the Human Resources Director. The safety manual and any amendments to it will be approved by the County Administrator before distribution.
- 2. The County Safety Officer will develop and maintain a comprehensive safety program for all departments, with the exception of the Sheriff's Department, which shall maintain its own safety program. The County's program will include the safety manual, handbooks, training programs, and educational materials designed to promote safe behavior in the workplace. The Safety Officer will be responsible for ensuring that County employees understand their responsibilities under the safety program, whether directly or through their department heads.
- 3. Department heads are responsible for ensuring that their employees adhere to and participate in the County's safety program. Employees are required to report unsafe conditions to their supervisor or Department Head. Employees may alert the Safety Officer directly of any safety concerns.
- 4. The County Safety Officer is authorized to stop work at any County work site if he/she determines that there is an imminent risk of injury or loss of life to anyone at the work site.
- 5. The County Safety Officer will inspect work sites periodically to note adherence to or violations of, the guidelines and requirements contained within the County's safety program.
- 6. Instances of failure to comply with this policy, as identified by the Safety Officer or any Department Head shall be resolved at the applicable Department without delay; and all such instances reported to the County Administrator.
- 7. Any instance of failure to comply with this policy that is not resolved in a timely manner will be referred by the Safety Officer immediately to the County Administrator to initiate appropriate corrective action through the applicable Department Head, who will apprise the County Administrator of resolution of non-compliance.

Resolution No. 219

Establishing Fee for County Treasurer to Collect Taxes on Behalf of Towns

Whereas, Article 5-G of the New York State General Municipal Law, together with Section 578(2)(a) of the New York State Real Property Tax Law allows municipalities to enter into municipal cooperation agreements for tax collection services by the County Treasurer, and

Whereas, Certain towns within Jefferson County have evinced interest in having the County Treasurer perform tax collection services on behalf of the towns, and

Whereas, If such an arrangement is made with a town, the County Treasurer is delegated to be the sole and exclusive authority to collect said Town/County taxes, and

Whereas, The County Treasurer will be responsible for all of the duties necessary with regard to the collection, processing and accounting for all of the Town/County taxes and any other assessments, fees interest and penalties thereof.

Now, Therefore, Be It Resolved, For any town desiring to enter into such cooperation agreement the County Treasurer shall charge for tax collection services under agreements approved pursuant to Real Property Tax Law Section 578 according to the following fee schedule:

- Up to 1,000 tax parcels: no fee
- Each tax parcel in addition to the first 1,000: \$1.50 per parcel

Resolution No. 220

Opposing COVID-19 Vaccine Mandates Imposed by Federal, State, or Local Government

Whereas, President Joseph R. Biden has announced plans to direct the U.S. Department of Labor's Occupational Safety and Health Administration ("OSHA") to develop an emergency temporary standard ("ETS") directed at private-sector businesses with one hundred (100) or more employees to require their employees to either be vaccinated against the COVID-19 virus or require any workers who remain unvaccinated to produce a negative test result on at least a weekly basis before coming to work, and

Whereas, Former Governor Andrew M. Cuomo announced in August of this year that all healthcare workers in New York State, including staff at hospitals and long-term care facilities will be required to be vaccinated and Governor Kathleen C. Hochul has vowed to enforce this mandate, and

Whereas, It is anticipated that the OSHA ETS could impact over 80 million workers in private-sector businesses with one hundred (100) or more employees, and

Whereas, Private-sector employers are already overburdened with unnecessary regulations, and

Whereas, Staff members within the medical field are already reported to be leaving their chosen fields of employment rather than abide by a mandated vaccination, and

Whereas, Medical treatment and preventative measures are an individual's choice, made in consultation with their medical provider, and that the government should not interfere with such choices, and

Whereas, It is not the County's, the State's, or the Federal government's responsibility to create mandates that force the general public to accept COVID-19 vaccinations against their will, and

Whereas, Jefferson County has led a successful campaign to ensure that residents of the County who want to be vaccinated against the COVID-19 virus have access to the vaccines, and

Whereas, Every citizen who wants a COVID-19 vaccine possesses the right to obtain one, but no COVID-19 vaccine should be mandated by law, and

Whereas, People have the right to refuse COVID-19 vaccination based on religious or medical reasons, and every medical intervention requires informed consent and the right of refusal, including the COVID-19 vaccine.

Now, Therefore, Be It Resolved, That the Jefferson County Board of Legislators expresses its opposition to COVID-19 vaccine mandates and any other similar legislation, order, ordinance, or

regulation by any local, state or federal government that affects a citizens rights to make their own health care choices, and

Resolved, That while the Board of Legislators opposes a vaccine mandate we remain committed to encouraging all those citizens who make the individual choice to get vaccinated against the COVID-19 virus to do so and to avail themselves of the many opportunities to receive the vaccine, and be it further

Resolved, That a copy of this resolution be sent to all of our elected State and Federal representatives.

Seconded by Legislator: Robert W. Cantwell, III

Instead of going through the four pages of notes he prepared, Legislator Montigelli presented an analogy of a large number of people on a boat together and one person decides to cut a hole in his cabin and water starts rushing in and the other passengers are upset by his behavior, but it is his own cabin so why should it matter; demonstrating that personal choice only goes so far when we are all in the same boat.

Legislator Maxon pointed out that there is nothing in the resolution that denigrates health care workers who have put so much time into the pandemic, it is particularly about government overreach, specifically by OSHA. He supported the resolution because the mortality rate of Covid does not warrant vaccine mandates being necessary, and said it would be more to the point to ask who stands to benefit financially from the government mandating them.

Legislator Jareo supported the resolution as in addition to his concerns about personal liberties and government overreach, there is a labor shortage and mandating vaccinations could damage the workforce further.

Legislator Peck said we are already feeling the impact of the mandates in our hospitals and health care facilities with staff shortages; it seems counterproductive to directly tie mandates to someone's employment. He expressed support for the resolution because at this point people understand the risk involved in voluntarily not receiving a vaccine, and the vaccine has not been proven well enough to warrant it being mandated.

Whereas, Jefferson County remains committed to pursuing affordable housing resources to assist low to moderate income County residents to improve the quality of the County's housing stock, and

Whereas, Jefferson County intends to apply for 2021 Federal Community Development Block Grant (CDBG) funds from the NYS Office for Community Renewal, and

Whereas, The County issued a Request for Proposals for the three year period 2019-2021 to identify qualified community development firms that could assist with grant preparation, program development, and program implementation for CDBG housing assistance initiatives, and

Whereas, Through the RFP process, Avalon Associates was identified as having the required credentials, expertise, and experience to assist the County in developing a CDBG housing application for a sum of \$7,500, which would be a County cost and is contained in the 2021 Budget, and

Whereas, Avalon Associates has also proposed, if a CDBG grant is awarded, to develop the housing program and assist in grant administration for a lump sum of \$15,000 (eligible grant

expense); provide program delivery services (e.g., qualifying applicants; inspecting properties; preparing loan and construction documents) for \$2,250 per housing unit (eligible grant expense); and fixed general and grant administration services fees as authorized by the grant program (eligible grant expense).

Now, Therefore, Be It Resolved, That Jefferson County enter into an agreement with Avalon Associates as described for the terms above for the 2021 CDBG Housing Grant, and be it further

Resolved, That the Chairman of the Board of Legislators is hereby authorized and directed to execute said agreement on behalf of Jefferson County, subject to the review of the County Attorney as to form and content, and be it further

Resolved, That the Chairman of the Board is hereby authorized to execute all necessary CDBG application documents, and the Department of Planning is hereby authorized as the County's agent to act in connection with the submission of any authorized application and to provide any supplemental information that may be required by the NYS Office of Community Renewal.

Whereas, Having reviewed the criteria contained in 6NYCRR, Section 617.7, Jefferson County finds that there will be no significant adverse environmental impact resulting from the digital update, minor reroutes and addition to the snowmobile trails through Jefferson County, and

Whereas, Jefferson County Board of Legislators passed Resolution No. 89 of 2021, establishing an annual budget for funds awarded from New York State Parks, Recreation and Historic Preservation for maintenance services to be performed by each snowmobile club pursuant to an annual agreement governed by New York State Parks, Recreation and Historic Preservation program requirements, and

Whereas, It is the County's intent to support the development and maintenance of snowmobile trails as an important economic and recreational resource for Jefferson County, and

Whereas, An Environmental Assessment Form has been completed which reviews potential environmental impacts and determines that no significant impacts will occur.

Now, Therefore, Be It Resolved, That Jefferson County shall assume lead agency status for this action pursuant to State Environmental Quality Review Act and has determined that this is an unlisted action and will not have any adverse environmental impacts, and be it further

Resolved, That the Chairman of the Board of Legislators is hereby authorized to sign the Environmental Assessment Form and the Determination of Significance and forward same to all involved agencies.

Whereas, The District and proposed modifications were referred to the Jefferson County Agriculture and Farmland Protection Board for its review and recommendations, and

Whereas, The report of the County Agriculture and Farmland Protection Board with its recommendation to modify and re-establish the district for eight years has been duly received by this Board of Legislators, and

Whereas, A public hearing was held on July 19, 2021 at which time consideration was given to the original Agricultural District, the recommendation of the County Agriculture and Farmland Protection Board, and the proposed modifications to the District.

Now, Therefore, Be It Resolved, That, Pursuant to Section 303-a of the New York State Agriculture and Markets Law, the Jefferson County Board of Legislators does hereby modify and re-establish the Jefferson County Southeast Agricultural District, No. 1, to consist of 52,492 acres of land, for a period of eight years. The modified boundary is depicted on a set of maps

entitled Jefferson County Southeast Agricultural District, No. 1.

Resolution No. 237

Authorizing Agreement with Samaritan Medical Center for Participation with Low Income Drug Discount Benefits Through Section 340B of the Public Health Services Act

Whereas, the United States Congress has authorized a discounted prescription drug benefit under the Public Health Services Act, Section 340B, for low income individuals who are not in receipt of Medicare or State Medicaid, and

Whereas, Public and private health care agencies may enroll in said program, however private health care providers must enter into an agreement with a governmental unit as a condition of eligibility for participation in the program, and

Whereas, Such Agreement requires no commitment on the part of the County other than to verify that the health care agency serves the target patient population, and

Whereas, By Resolution 175 of 2019, this Board of Legislators authorized an agreement with Samaritan Medical Center for the purpose of establishing its eligibility for participating in the 340B program, and

Whereas, Samaritan Medical Center has requested that the agreement be renewed for another two years.

Now, Therefore, Be It Resolved, That the Chairman of the Board is hereby authorized and directed to execute an agreement with Samaritan Medical Center for a period October 1, 2021 through September 30, 2023 for the purposes set forth above, subject to the approval of the County Attorney as to form and content.

Chairman Gray announced legislator appointments to the following:

Ad Hoc Committee on Appointments: Legislators Jareo, Drake, Cantwell, McBride and Calarco. He advised that the Committee will be tasked with finding people interested in filling open positions on the advisory boards, excluding reappointments and appointments made by the Chairman of the Board. He said the Committee can meet with as few as three members to make recommendations, and Administration will call the meetings when vacancies exist.

Ad Hoc Committee on Redistricting: Legislators Johnson, Peck and Doldo. Chairman Gray said he has spoken to the Planning Department concerning redistricting and they are prepared to move forward, and the Committee should provide final recommendations by March, 2022.

Legislator Maxon took issue with quarantine order documents that were sent out to Covid-19 positive patients, from the Jefferson County Public Health Service per New York State directives as they contain very strong language concerning Covid-19 protocols that is being taken literally, resulting in isolation of very young children within their homes, and also threatens legal action for non-compliance.

There being no further business of the Board, on a motion by Legislator Maxon seconded by Legislator Montigelli and unanimously carried, the meeting was adjourned at 6:37 p.m.
