REGULAR SESSION

TUESDAY, SEPTEMBER 7, 2021

Chairman Gray called the meeting to order at 6:00 p.m.

ROLL CALL OF MEMBERS

All members present except Legislator Ferris.

PRIVILEGE OF THE FLOOR

Tammy Castor, Adams Center, NY addressed the Board to speak out against Covid-19 mandates. She also took issue with testing products and vaccines ingredients saying they are unsafe, and said vaccines are not effective. She spoke against children wearing masks and said doctors are censored from speaking out and any information that is released is controlled in order to gain peoples' compliance.

Chris Robl, Pierpont Manor, NY and City of Watertown firefighter addressed the Board to speak out against FDA approval of Covid-19 vaccines as it paved the way for employer mandated Covid-19 vaccines and to begin experimenting on low risk children, both of which he is opposed to. He is also opposed to any laws that mandate Covid-19 vaccines, and the vaccines themselves as he said they are not safe or effective, despite the narrative put out in the media.

Carter Young, Theresa, NY addressed the Board concerning a delinquent tax property at 38194 County Rt 37 formerly known as McGinnys Mobil in Theresa, NY that has not been in operation for at least five years. He said he has made a deal with the current owner to buy the property, pay the back taxes and he would do the environmental clean up necessary, however it has come to a standstill because of liens totaling over \$200,000 on the property. He asked the County to consider taking over the property temporarily, removing all the liens, and selling it to him for the amount of the back taxes. He would then do all the environmental clean up that is necessary and put a viable business on the property. He provided two proposals quoting the clean up work.

Rob Aliaso, Town of Henderson, NY who holds a position on Town of Henderson Zoning Board and is JCIDA Treasurer said it looks like the National Oceanic and Atmospheric Administration (NOAA) will be designating part of Lake Ontario and the St. Lawrence River in Jefferson County as a Marine Sanctuary including parts of the Lake in Oswego, Wayne and Cayuga counties. For every area designated as a Marine Sanctuary by NOAA they also site a marine heritage center within its boundaries for historical purposes. Mr. Aliaso is part of a grass roots group from the Town of Henderson that is looking at the best way to attract such a center to Jefferson County as it would be an asset in many ways. He asked the to Board to consider taking a leadership role in soliciting NOAA to site the marine heritage center in Jefferson County before it is requested by the other counties.

Pete Price, Henderson business owner and resident, and member of the grass roots effort

to attract the NOAA Marine Sanctuary visitors center to Jefferson County said NOAA's interest in preserving the history of our natural resources is an opportunity that requires all in action. He said we need to pursue the center with a multi-faceted, coordinated effort displaying Jefferson County in the best light as the area's natural and historical assets are second to none, we have the very best product to fit NOAAs needs, and if located here could reap us tremendous rewards.

Legislator Nabywaniec left the meeting.

Whereas, The Project had to be re-bid this spring and construction costs increased since 2019 with a revised expected total cost of \$1,504,177, and

Whereas, By Resolution 145 this Board authorized the use of \$97,639 of the Capital Chargebacks committeed in Resolution 87 of 2019 as local match to state funding of \$97,639, and

Whereas, New York State has previous funding from SUNY 1998 advance for JCC capital projects of which \$29,538 remains available, and

Whereas, JCC wishes to designate an additional \$29,538 of the Capital Chargebacks committed in Resolution 87 of 2019 to provide the local match for the additional state funding of \$29,538, and

Whereas, The JCC Faculty Student Association has committed to cover any gap in funding the Project between the EFC \$880,000, SUNY \$127,177 and Capital Chargebacks \$497,000.

Counsel has advised that the range of possible verdicts includes the possibility of a verdict of "no cause for action," but also may include an adverse verdict in an amount which is in the discretion of the jury and which exceeds the settlement demand of the plaintiff; and that the substantial costs of proceeding to trial—including both the labor and opportunity costs of making senior employees of the County available throughout the trial; the costs of attorney preparation and presentation of trial; and the costs to be incurred for our expert witnesses in preparing for and testifying at trial serve to offset the total cost of settlement to the County; at the same time that a settlement defines the extent of expense and removes the threat of uncapped exposure.

Whereas, Pursuant to Local Law No. 5 of 1986, a settlement or comprise of a claim in the amount of more than \$10,000.00 requires the approval of the Board of Legislators,

Now, Therefore, Be It Resolved, That for purposes of avoiding the costs and expense of a trial; and for purposes of compromising a claim at a point well within the estimated range of possible jury verdicts, the Board of Legislators does hereby agree to a settlement of the matter herein; and the sum of Twenty Thousand Dollars (\$20,000.00), be and hereby is appropriated from Account: 45193000 04600, the Judgment and Claims Fund, for purposes of settling the referenced litigation against the County of Jefferson; and the County Attorney is hereby authorized to tender that sum to counsel for the plaintiff, upon such terms and conditions as counsel agree, upon receipt of a Release of all claims in a form acceptable to the County Attorney and receipt of a fully executed Stipulation of Discontinuance.

Chairman Gray entertained a motion to waive Standing Rule 45 to reconsider Resolution No. 172 "Appointing Member to Jefferson Community College Board of Trustees" due to an error in the term. A motion to wavie Rule 45 and reconsider the resolution was duly made by Legislator Maxon seconded by Legislator Doldo an unanimously carried.

In response to questions concerning certain Standing Rules being waived Attorney Paulsen said in this particular instance only waiving Rule 45 is appropriate and as it is not necessary to waive all of the Rules. Chairman Gray said when he was first on the Board particular Standing Rules were waived and we have gotten away from it. He felt it was a good idea to go back to that as many times it is not necessary to waive the Standing Rules in their entirety. He said once the issue that the rule(s) have been waived for is concluded, all the Standing Rules are back into effect.

Chairman Gray entertained a motion and second to amend the resolution to reflect the term to expire on 6/30/2028. A motion was duly made by Legislator Johnson seconded by Legislator Doldo and unanimously carried. All members present voted aye on Resolution No. 172, as amended, except Legislator Jareo who voted nay for reasons stated last month concerning advisory board appointments.

Chairman Gray entertained a motion and second to go into executive session to discuss a settlement on Resolution No. 195 and separate litigation. Such motion was duly made by Legislator Peck seconded by Legislator Drake and unanimously carried; the Board entered executive session at 6:45 p.m. The Board returned to open session at 7:12 p.m. on a motion by Legislator Doldo seconded by Legislator Cantwell and unanimously carried.

**All members present voted aye on Resolution No. 195.

Legislator Peck advised that he spoke to Administration, Public Health Director Hall and Public Health Planner Stephen Jennings concerning questions that were raised at the Health & Human Services Committee meeting concerning the potential for reporting the vaccination status of Covid-19 hospitalizations and positive cases. He said hospitalization information is not readily available and explained that the other County that released hospitalization information had a specific arrangement with their hospitals to do so, and an inquiry has been made, but no answer has been given.

With regard to the Covid positive cases he said it is difficult to tell from the data we can look at for many reasons, i.e. the NYS Comm Care system that tracks positive cases, and the NYS Immunization Information System that tracks vaccinations do not interact/talk to each other; contact tracing relies on the trustworthiness of the person answering the questions. Also, unique to Jefferson County is the federal government presence; the federal government system is not accessible to Jefferson County and also does not interact with the New York State systems. The federal system not only includes active military on Fort Drum, it can include people who are out of state, VA patients, retirees, etc. and we have no way of knowing or checking on the status

of vaccination or Covid positive cases. All of this is a lot of information that is not easily compiled and he said the Public Health Director is not going to provide information she does not have a great comfort level that it is accurate and detailed to be able to present publically. She wants to be able to ensure that the data is good enough that it is not going to create all kinds of concerns, or that you have to add on so many disclaimers that you question whether the data is good. He mentioned that the CDC tracking of breakthrough cases and the level of severity and level of morbidity of those vaccinated is a much more important figure to track rather then simply vaccinated vs. unvaccinated.

Legislators Doldo and Jareo expressed concerns and would not support the County taking over the property in Theresa as requested by Mr. Young at the beginning of the meeting. The environmental component is the biggest concern, but it is not as simple as the County taking title and wiping out liens, which is not equitable or fair to the lien holders.

County Attorney Paulsen advised that it is too dangerous for the County to take title to the property until the clean up is done to the DEC's satisfaction. At that point we can negotiate with the DEC and the spill fund to obtain a release, as we have done with other properties and been successful at selling them at auction. If the County took title before that clean up then we would have to be guaranteed that the County/taxpayer will not be on the hook for contamination, and it is hard to expect that from a private citizen. The second problem would be if the County took title to the property we can not convey it to an individual, it would have to be offered in a public manner.

Chairman Gray advised that the eviction moratorium has been extended to January 15, 2022 and there are caveats; the landlord can challenge the tenant's hardship, and the hardship has to be pandemic related; a court order can be obtained that requires the tenant to file the Emergency Rental Assistance Program (ERAP) application for assistance; and the State has added more money to the ERAP program. He added that if the tenant is inflicting damage or nuisance on the apartment, there is a path forward for eviction.

Legislator Cantwell expressed concern about someone getting hurt at the Rainbow Motel property as in addition to the fire damage there is also a vehicle with no license plates on the property now, and asked what town it is in and if the County has responsibility for code enforcement. Administrator Hagemann advised that it is in the Town of Pamelia, they have their own code enforcement officer and concerns have been expressed to the Town Supervisor with regard to the condition of the property and potential insurance issues. He said the Town Supervisor assured that the Town Board would be addressing it.

There being no further business of the Board, on a motion by Legislator Maxon seconded by Legislator Doldo and unanimously carried, the meeting was adjourned at 7:25 p.m.
