COUNTY PLANNING AND ECONOMIC DEVELOPMENT

Community Development Block Grant (CDBG) Housing Program:

COMMUNITY PLANNING AND DEVELOPMENT

Municipal Project Assistance

Alexandria Bay (v) – Staff met twice with the Zoning Update Committee to discuss the schedule of uses that include modern uses and simplification as well as new uses and began discussing definitions. Continued to review current, updated and new use related definitions, modifications to the proposed schedule of uses and started looking at and general and specific use criteria. Prepared zoning map with buffers around schools and parks for planning purposes.

Black River (V) – Preliminary zoning map revised as village requested and presented to village for approval.

Chaumont (V) - Staff finalized the Village's Zoning Map and Text amendments in order for final adoption.

LeRay (T) Comprehensive Plan Update – Staff met twice with the committee to discuss the process, review and finalize land use survey questions and discussed potential additional members and potential public meeting ideas. Composed survey area/neighborhood map and 2020 land use by assessment map. Also reviewed some population and housing trends. Created ZIP code map, historic sites map, housing age map, locator map, and major landforms map for inclusion into the Comprehensive Plan.

Orleans (T) – Staff completed final edits for the Town's update to its Solar/Battery Regulations.

Adams (V) Staff met with the Village Planning Board to discuss process for amending their zoning law to include solar energy regulations.

Training

Staff viewed various webinars for training purposes on solar energy development, battery storage, wetland protection, cannabis regulation, short term rentals and other topics.

Staff is coordinating with NYSDOS staff for an in-person land use training session in September.

RESOURCE AND ENVIRONMENTAL MANAGEMENT

<u>Agriculture</u>

Southeast District 8 Year Review. The Agricultural and Farmland Protection Board reviewed the Southeast Agriculture District. A public hearing was held and the district is currently undergoing a coordinated SEQR review with the NYS Department of Agriculture & Markets.

CLEAR (Coastal Lakeshore Economy and Resiliency Initiative)

Staff participated in three virtual meetings on the CLEAR process regarding municipal resiliency to water level extremes along Lake Ontario and the St. Lawrence River. <u>https://www.northcountryclear.com/</u>

Snowmobile Grant-in-Aid Program

Staff submitted and completed two clubs Phase I gps map updates for their trail systems. Requested the forms and information required from the five snowmobile clubs to submit to NYS OPRHP for the annual application due September 1.

MS4 Coalition

Staff attended a quartery meeting in person.

NYS Septic System Replacement Program

Jefferson County was notified that the target areas for this grant was extended to include the St. Lawrence River and Guffin Bay.

Staff is compiling a list of interested homeowners. Staff is preparing grant selection criteria in order to accommodate more homeowners.

Awarded a grant to replace a failing septic system for a primary residence in the Town of LeRay located on the Indian River pursuant to Round 1 of the Program.

Continued to address questions and compiling an interested participant list for funding pursuant to Round 2 of the Program. Creating criteria to review and rate applications for Round 2 of the Program.

INFORMATION, DEMOGRAPHIC, AND DATA SERVICES

General Technical Assistance

Responded to callers, emails, and walk-ins with requests concerning flood maps, parcels, zoning, and county map viewer.

Other Geographic Information System (GIS) Tasks (not associated with projects above)

Our GIS Specialist supports planners with various projects and other County Departments. Examples include: digitizing radio tower layer and editing the associated department spreadsheet; creating 2020 land use by assessment map for Village of Alexandria Bay comprehensive plan; producing the 2020 village map series of New York State Certified Agricultural Districts to post on the Planning webpage; create 2020 Jefferson County map of New York State Certified Agricultural Districts; prepared agricultural priority soils map for proposed solar farm in the Town of Watertown; and continued updating the Economic Indicators spreadsheets for the county. Revisions to Southeast Agricultural District modified parcel maps and developmental pressure map and updated modified acreage summary tables; provided Dog Control Enforcement map to Dog Control office; researched and mapped highly distressed Census tracts for the American Community Five-Year Survey of 2012 for Jefferson County; formatted Real Property 2021 parcel layer for use in GIS and to post to the County Map Viewer; created 2021 land use by assessment map for Jefferson County; added 2021 summary table to the Parcel Summaries workbook.
