# Planning Department Report April – May 2021

### **COUNTY PLANNING AND ECONOMIC DEVELOPMENT**

Community Development Block Grant (CDBG) Housing Program:

LeRay (T) Comprehensive Plan Update – Staff met with Town Planner, Zoning Officer, and Planning Board chair to discuss the process and meeting options. Scheduled the committee meetings and discussed potential public meeting ideas.

#### CLEAR (Coastal Lakeshore Economy and Resiliency Initiative)

### Snowmobile Grant-in-Aid Program

Staff submitted the Phase III documentation verification for the five clubs to NYS OPRHP. Staff also submitted Phase I gps trail update for the two clubs.

#### MS4 Coalition

Staff submitted the MS4 Annual Report for Jefferson County consistent with the Stormwater Coalition cooperation and input from the JC Highway Department.

#### NYS Septic System Replacement Program

Jefferson County was notified that the target areas for this grant was extended to include the St. Lawrence River and Guffin Bay.

Staff is compiling a list of interested homeowners. Staff is preparing grant selection criteria in order to accommodate more homeowners. Staff facilitated a conference call with staff from NYS EFC and Indian River Lakes Conservancy to discuss program impleemntation.

#### Black River Recreation Trail Extension

Staff observed the Watertown-Jefferson County Area Transportation Council presentation of a study on bicycle and pedestrian connectivity to extend the trail from Black River to Great Bend.

#### **INFORMATION, DEMOGRAPHIC, AND DATA SERVICES**

#### General Technical Assistance

Responded to callers, emails, and walk-ins with requests concerning flood maps, parcels, zoning, and county map viewer.

### Other Geographic Information System (GIS) Tasks (not associated with projects above)

Our GIS Specialist supports planners with various projects and other County Departments. Examples include: Digitize proposed and built solar projects in the County, map them, and determine amount of priority farmland soils and core farmland areas impacted by projects; update solar farms maps and spreadsheet as more projects came in; create maps of 2015 aerial imagery versus 2020 imagery of solar farm locations; map County-owned land and create accompanying spreadsheet; update Town of Wilna Overhead map to post to department Resource Maps webpage.
