Authorizing the Implementation and Funding in the First Instance 100% of the Federal Aid and State "Marchiselli" Program Aid Eligible Costs of a Transportation Federal-Aid Project (Noble Street over West Creek) and Appropriating Funds Therefor

Whereas, A Project for Noble Street over West Creek, PIN 775377 (the "Project") is eligible for Funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% federal funds and 20% non-federal funds, and

Whereas, By Resolution 209 of 2019, the County of Jefferson approved the above project by making a commitment of \$195,000 for the cost of the Preliminary Design and Right of Way Incidentals Phase, and

Whereas, The County of Jefferson desires to advance the Project by making a commitment of 100% of the non-federal share of the cost of the Right of Way Acquisition Phase of the Project, and

Whereas, The County has allocated a total of \$500,000 to this project through the Adopted 2019, 2020 and 2021 County Budgets.

Adopting Guidelines and Administrative Procedures in Relation to the County's Housing Improvement Program Funded by a 2020 NYS Community Development Block Grant (CDBG) Award

By Legislator:

Whereas, By Resolution 174 of 2021, the Jefferson County Board of Legislators accepted a Community Development Block Grant (CDBG) for the 2020 Program Year (581HR116-120) from the New York State Office of Community Renewal to implement and administer a county-wide Housing Improvement Program, and

Whereas, Local Guidelines and Administrative Procedures have been developed for implementation and administration of the program in compliance with applicable federal, state and local regulations, and

Whereas, The Guidelines and Administrative Procedures are updated for each CDBG housing award to incorporate changes to meet program and regulatory requirements associated with the award, and

Whereas, The Guidelines and Administrative Procedures must be adopted by the Board of Legislators.

Now, Therefore, Be It Resolved, That this Board of Legislators, having been provided with a draft copy of the Guidelines and Administrative Procedures for Jefferson County for the 2020 grant award hereby adopts them and they shall become effective immediately for all County-sponsored housing rehabilitation activities conducted with 2020 Small Cities Community Development Block Grant funding.

A requirement of CDBG housing Awards is that the municipality have written Guidelines. The Board has approved such guidelines previously with minor changes to keep up with current regulations and housing construction trends.

Changes to the 2020 CDBG housing Guideline:

• The project area still includes all areas in Jefferson County except the city of Watertown where other federal and state funding is available to support housing rehabilitation activities (see Section 1.2).

• Eligibility is limited to owner-occupied properties and we can work with 1-3 unit projects as long as one of the units is occupied by the property owner (see Section 3.1). The state has created a separate category for 4+ unit properties, which will generally be absentee-owned.

• Absentee-owned rental properties will not be eligible for assistance under the county-wide Housing Improvement Program (see Section 5.2).

• Mobile homes will not be eligible for assistance under the county-wide Housing Improvement Program (see Section 5.3).

• Section 6.6 includes language to prohibit any activities in Coastal Zones or Coastal Barrier Resource Areas and to require NYS-DEC approval for any project that includes work on wells or septic systems in or adjacent to a wetland area. Those restrictions come from the environmental review process that was required for this grant.

• Section 6.7 details rules for Program Income that were established by the Office of Community Renewal effective March 31, 2019. Under this rule, income received from loan repayments, grant recaptures and other sources is Program Income if the total of those funds exceeds \$35,000 during any state fiscal year (April 1 through March 31); and those funds must be returned to the state. If those receipts total less than \$35,000 during the fiscal year, they are Miscellaneous Revenue that can be retained by the county.

• Section 8.5 details the requirement for releases from each applicant giving the county and the NYS Housing Trust Fund Corporation (HTFC) the unrestricted right to use photographs taken of the property and/or the applicant and releasing the county and the state from any liability for use of those materials.

• Grant limits have been set at \$35,000/unit to allow us to work with larger projects where more work is needed to bring properties up to code standards. Most of those projects will require abatement of lead paint because the rehabilitation cost and/or HUD funding exceeds the \$25,000 threshold for "interim controls". That work will be included in the rehabilitation contract for each project and the contractor will be expected to use a subcontractor who is licensed to perform lead abatement if they are not qualified for that work (see Section 9.4).

• Projects will be reviewed by the State Historic Preservation Office (SHPO), by the Tribal Historic Preservation Office (THPO) and by the DEC (for work in sensitive environmental areas). The THPO review is required only for projects that include ground disturbance (eg: for septic systems) where buried artifacts might be affected (see Section 9.6).

• Appendix A includes target area maps and the current Income Limits and Rent Limits that are used to determine eligibility for assistance under this program. The target area includes all of Jefferson County except the city of Watertown where similar financing is available for housing rehabilitation

activities. The Income Limits and Rent Limits are revised annually based on updated information from HUD.

• Appendix B includes a Lead-Based Paint Hazard Reduction Plan detailing the procedures for projects where full lead abatement is required because the rehabilitation cost and/or HUD funding exceed the \$25,000 limit for "interim controls".

• Appendix C includes a Green Rehabilitation Plan detailing procedures to address basic repairs that will improve energy efficiency, household health and basic shelter safety.

• Appendix D includes materials detailing the National Healthy Housing Standard that was developed by the National Center for Healthy Housing. This manual, together with the Model Rehabilitation Standards produced by the National Center for Lead-Safe Housing are the minimum standards for all improvements to be completed under this program.

• Appendix E includes an outline of the Cultural Resource Information System (CRIS), which is an on-line system to facilitate review of rehabilitation projects with the State Historic Preservation Office (SHPO) to assure that these activities will not adversely affect historic or cultural resources in the state. Also included is contact information for three recognized Indian Tribes with interests in Jefferson County. Those contacts will be used for any project that involves ground disturbance (eg: for wells or septic systems) to assure that cultural resources are not damaged by those activities.

• Appendix F includes all of the forms that have been developed for this program. Several of those forms have been revised to accommodate changes in the program guidelines.

Other Geographic Information System (GIS) Tasks (not associated with projects above)

Our GIS Specialist supports planners with various projects and other County Departments. Examples of GIS projects for 2021 include: Development Pressure maps to evaluate agricultural protection needs; Legislative Redistricting maps for Proposed Plans 4 and 5 showing changes form 2010 and new district population figures, development of Census data to include LATFOR population redistribution numbers, maps of Legislative Redistricting Proposed Plans 1 through 3 with LATFOR population figures, and creating and updating tables with 2010 to 2020 population changes with current districts and proposed districts according to the various plans, tables of on/off Fort Drum populations for proposed districts in LeRay, tables for municipal populations of each district per plan, tables of percent deviation for adjacent district populations, and tables of total deviation for all districts.
