Whereas, It is desirable to utilize the professional services of a consultant experienced in preparation of cost allocation plans in the development of Jefferson County's Cost Allocation Plan as a means of insuring maximum federal reimbursement, and

Whereas, In response to a request for proposals, three proposals were received and reviewed in detail.

Now, Therefore, Be It Resolved, That Jefferson County enter into an agreement with Maximus, Inc. for professional services in the development of central services cost allocation plans based on actual costs for 2020, 2021, 2022, 2023, and 2024 with an option for 2025, including related documents in conformance with Federal Office of Management and Budget requirements, consideration to be paid shall be \$8,500 for each of the 2020, 2021, and 2022 years, and \$8,675 for each of the 2023, 2024 and the optional 2025 years, and be it further

Resolved, That, pursuant to Section 450 of County Law, the Chairman of the Board of Legislators be and is hereby authorized and directed to execute such contract on behalf of Jefferson County, subject to approval by the County Attorney as to form.

Resolution No. 65

Requesting The New York State Legislature Provide Level Funding for the Northern New York Agricultural Development Program in the FY2022 State Budget at \$300,000

Whereas, The Northern New York Agricultural Development Program was established by the New York State Legislature in 1961 as a farmer-driven small grants program funding high priority, cutting-edge research and technical assistance in all sectors of agriculture in Jefferson, Lewis, St. Lawrence, Clinton, Essex, and Franklin Counties, and

Whereas, This critical funding is administered by the NYS Department of Agriculture and Markets and implemented by a steering committee of nearly 100 local farmers representing the diverse agricultural sectors in NNY and farm enterprises of all sizes, and

Whereas, Projects selected for funding by the steering committee involve important onfarm research which provides NNY farmers with practical, real-world results to guide innovative agricultural practices shaped by the region's unique soils, climate and short growing season, and

Whereas, The NNY region is ranked second in the State for agricultural production with annual farm product market values in excess of \$776.5 million, thus making agriculture a driving economic engine important to local, regional and State economies, and

Whereas, Funding for the Northern New York Agricultural Development Program was dramatically reduced in the FY2021 State Budget, representing a 50% drop in historical funding levels from \$600,000 to \$300,000, and

Whereas, Funding for the Northern New York Agricultural Development Program was not included in the FY2022 Executive Budget, nor has it ever been in an Executive Budget as it is a New York State Legislature initiative.

Now, Therefore, Be It Resolved, That the Board of Legislators requests the New York State Legislature provide level funding for the Northern New York Agricultural Development Program in the FY2022 State Budget at \$300,000, and be it further

Resolved that copies of this resolution be forwarded to Senator Patty Ritchie, Senator Michelle Hinchey, Chair of Senate Committee on Agriculture, Assemblyman Ken Blankenbush, Assemblyman Mark Walczyk, Assemblyman William Barclay, and Assemblywoman Donna Lupardo, Chair of Assembly Committee on Agriculture, St. Lawrence County Board of Legislators, Lewis County Board of Legislators, Clinton County Board of Legislators, Essex County Board of Supervisors, and Franklin County Board of Legislators.

It is a very diverse type of ag funding that is very significant to a lot of farmers and agricultural producers in the Adirondacks and over into our region. He said it is unfortunate that the Governor, every year,

does not see the value of the program so the State Legislature has to inject the money back into the Budget for the Program.

Resolution No. 79

Adopting NYSPHSAA Guidelines for Return To Interscholastic Athletics

Whereas, School Districts within Jefferson County have been searching for guidance in Scholastic Athletics and spectators of athletics, and

Whereas, Athletes and parents of athletes should be able to enjoy the same joy of competition that others have had for decades, and

Whereas, Jefferson County's current guidance on spectators at athletic events is no longer applicable in the current pandemic climate, and

Whereas, School Districts have their own governing board which is charged with the safety and well being of their students and staff, and

Whereas, The New York State Public High School Athletic Association (NYSPHSAA) has brought forward a thought out set of guidelines for the return of interscholastic athletics.

Now Therefore be it Resolved, That the Jefferson County Public Health Department adopt the New York State Public High School Athletic Association (NYSPHSAA) guidelines for Return of Interscholastic Athletics dated 2/5/21, and be it further

Resolved, That School Districts and their sport organizers have the individual autonomy to decline sports practice or competition and spectators.

Seconded by Legislator: Jeremiah J. Maxon

Legislator Montigelli asked what the difference was between this resolution and the Press Release that Chairman Gray put out earlier today. Chairman Gray didn't know if there was a difference because he was not familiar with NYSPHSAA guidelines, but he said there are no provisions in the resolution for shutting things down if cases start going back up and the positivity rate increases. Legislator Montigelli said he has to vote no on the resolution not because he disagrees, but because it is last minute, it has already been addressed in a press release and he does not feel prepared to vote at this time.

Legislator Jareo said it is last minute and the provisions mentioned can certainly be added to the resolution and any amendments that are warranted can be entertained. His opinion was that decisions about sports going on pause should be up to the individual school districts as they are in different parts of the County and have different circumstances, but this gives them some guidance.

Chairman Gray suggested consulting with the Public Health Department as to their views about what should be put in the resolution concerning transmission rate and positivity rate before it is adopted as they are the experts in epidemiology, they are an authority on the virus and have to manage it and keep the community safe.

Legislator Jareo agreed that if the transmission rate is above 1% districts should be trying to work to contain it and that language can be added to the resolution, but it should be the school districts working directly with Public Health. He did not agree with using the positivity rate for anything. He said we should always be in consultation with our professionals, but we should not delegate our decision making to them. The school districts are much better equipped to be reactive to the needs of their students, staff, taxpayers and parents. The resolution does not create any barriers with Public Health, it allows the superintendents and school boards to do what they need to do to have a fully functioning school district according to the desires and the safety of their own constituents.

Legislator Peck was excused from the meeting.

Legislator Ferris said his goal is to get the schools and athletic programs open and he understood that the Chairman's goal is to do it safely. He supported the resolution because he has faith that the schools will be a partner with Public Health as to whether or not it is safe for their schools to move forward and he has faith that Public Health Director Hall will make the right decisions too, and thinks everyone can handle moving forward at this point.

Legislator Nabywaniec agreed with Legislator Montigelli and said he does not agree with last minute resolutions normally, however he supports this resolution because on *this* issue it feels like the County is being put in the middle. He has faith that the superintendents will do the right

thing and are well capable of following the guidelines that the NYSPHSAA have put out. He said the schools are more than capable of protecting their students and we should give them more ownership to run and manage this and to do a good job, and we don't have to be hovering over every decision on this.

Legislator Maxon agreed with Legislator Nabywaniec and said the most important part of the resolution is that it specifically points the responsibility at the school district. He said parents place their trust in their school boards and superintendents and they are far more capable of making nimble decisions than this Board. He said he will support the resolution as the people have asked, we have excellent guidance provided by the athletic association, and the schools are the best informed and the best on the ground to enforce whether they have sports practices, competition and attendance at their events.

Legislator McBride pointed out that the NYSPHSAA document says that if schools go 100% remote then all sports stop.

Legislator Drake said if the superintendents feel there is a health issue involving sports, regardless of this resolution, it appears they will shut everything down. He has every confidence that this resolution is the same as what was put out in the Chairman's Press Release and he has all the confidence in the world in the school administrations.

Chairman Gray said part of the problem is that there is tremendous conflict between what is in the Governor's Executive Order regarding events, guidance for school sports, wedding guidance and others, and it is all colliding with no clear and concise guidance from NYS. He called the question.

All members present voted aye except Legislator Montigelli who voted nay.

Legislator Montigelli expressed appreciation to Chairman Gray for his commitment and all the time that he has spent, on behalf of the Board, to resolve the issues of the pandemic for an entire year now. Chairman Gray said it isn't just him, there are a lot of dedicated employees, too numerous to mention, working very hard. He said we are 12 weeks into the vaccination process and that will bring everything home to a sense of normalcy.

There being no further business of the Board, on a motion by Legislator Montigelli seconded by Legislator Ferris and unanimously carried, the meeting was adjourned at 6:45 p.m.
