Whereas, It is most affordable to enter a five-year contract at \$107,078.87 annually, which is recommended by the Sheriff and Purchasing Agent.

Whereas, The County's airport consultant on this project, McFarland Johnson, intends to complete grant administration at a cost not to exceed \$5,000 and the County is expected to incur \$1,000 in reimbursable administrative expenses in relation to the project.
