COUNTY PLANNING AND ECONOMIC DEVELOPMENT

Community Development Block Grant (CDBG) Housing Program:

2020 Award: \$2,438 was processed for two rehab projects.

2021 Award: \$84,418 was processed for four rehab projects, program delivery, and administration.

North Country HOME Consortium
