TUESDAY, FEBRUARY 6, 2018

Chairman Gray called the meeting to order at 6:00 p.m.

ROLL CALL OF MEMBERS

PRIVILEGE OF THE FLOOR

Don Metzger, Jefferson County resident for 41 years, read a brief excerpt from a Watertown Daily Times article regarding the JCIDA adopting a Uniform Tax Exemption Policy (UTEP) that mirrors the policy the County adopted about two years ago with regard to payment in lieu of taxes (PILOTS) arrangements relative to alternative energy projects that generate more that 25 mega watts of power. Resolution No. 55

Amending the Policy of the Jefferson County Board of Legislators in Regard to the Abatement of Real Property and Other Taxation for Alternative Energy Projects.

Whereas, Review and application of the policy to date has lead to the possible interpretation that certain language in the policy is misleading and inaccurately limits the legal authority of the Board of Legislators and the County of Jefferson; and

Whereas, Amendment of the policy by deletion of the language struck out in the attached amended policy will remove any ambiguity as to the full range of authority of this Board with regard to taxation of alternative energy projects of less than 25MW.

Jefferson County Policy Statement on Wind Farm Development

Background

The interest by developers in the creation of commercial wind turbine generation farms in Jefferson County has seen a resurgence.

Currently in place in NY is Real Property Tax Law §487 which provides a fifteen year exemption from taxation of the incremental increase in value of real property created by the construction of solar, wind, or farm waste energy systems. All taxing jurisdiction have the right to opt out of this law and thereby eliminate the exemption.

Jurisdictions that do not opt out of §487 have the ability to require the owner of the property improved with a solar or wind system to enter into a payment in lieu of tax agreement with the taxing jurisdiction.

As an additional avenue, a developer has the right to seek from a NYS industrial development agency such as the Jefferson County IDA ("JCIDA"), an inducement resolution which could include a real property tax exemption and require the execution of a payment in lieu of tax agreement (a "PILOT").

County position on Real Property Tax Law Section 487

The County has analyzed its alternatives with regard to RPTL §487:

- (a) to permit the statutory fifteen year exemption to remain in place and, in those situations where there is no alternative tax exemption route, compel developers of wind or solar generation facilities to negotiate and execute a Payment in Lieu of Tax Agreement ("PILOT") with the County, or,
- (b) opt out of Section 487, thereby terminating the exemption for all solar, wind and farm waste systems.

Since commercial wind and solar system developers could still apply to the Jefferson County Industrial Development Agency for inducement as a project of the Agency, regardless of the County's action on RPTL§ 487, it is appropriate to leave the exemption in place to assist in the development of facilities smaller in size than 25 MW. , for which projects the County would not demand the execution of a PILOT. It is unlikely that those who would construct a solar, wind or other alternative energy generation system outside the context of a supplying a specific business would qualify for inducement by JCIDA. Therefore, the County has determined that it will (a) not opt out of §487 but require the execution of a PILOT for any project in excess of 25MW which PILOT will require annual payments comparable to the real property taxes that would be payable to the County if the facility was not tax exempt and (b) inform the Jefferson County IDA of the county's position on the level of payments it is seeking under a JCIDA PILOT.

Tax Treatment of Wind Farms

As a source of alternative energy, the County is not necessarily opposed to development of commercial solar or wind farms, but believes, the impacts and burdens placed on the community by such projects outweigh the benefits received by the community and that there is no justification for any reduction in the real property tax burden. The County does not support the assumption that the economic benefits to the region justify a reduction in the real property tax burden based upon the argument that any tax realized from development is better than no increase in development or tax revenue.

The County cannot support these projects simply because they provide renewable energy generation and will create construction jobs. While there may be a significant number of construction jobs, there is no guaranty that those jobs will be filled by County residents. The construction employment may provide income to various local businesses, but that cash flow will abate as soon as construction is completed. There is no long term benefit for the community that justifies granting the sales tax relief and the long term real property tax abatements being sought by developers.

Wind or Solar Farm PILOT Agreements

The County believes that a PILOT for commercial solar and wind farms in excess of 25 MW should require an annual payment to the County in an amount equal to that which would have been received by the County in the absence of an exemption. In reaching this conclusion, the County has based its determination on a series of factors which include:

- a. The impact of the NYS tax cap legislation on the County with the value of the proposed development eliminated from the calculation of the growth factor because of the PILOT exemption.
- b. The lack of permanent payroll and/or permanent jobs created.
- c. The potential decrease in fair market value of properties within the impacted area and the viewing zone; and, in turn, the impact that those changes in fair market value will have on the tax levy and the tax rate for all impacted taxpayers.
- d. The lack of secondary jobs created by the project.
- e. Impacts associated with noise and visualization of a project which may be a basis for varying treatment of solar versus wind farms.

Request of the Jefferson County IDA

The County is calling upon the JCIDA to draft, adopt and thereafter follow a modification to its Uniform Tax Exemption Policy that:

a. Provides for annual PILOT payments to the County in an amount equal to that which

the County would have received in real property taxes in the absence of an exemption. This assumes that the IDA will establish a per MW PILOT payment schedule at a level sufficient to fulfill the requests of all of the impacted taxing jurisdictions taking into account the County's requirement and undertake the process to obtain the consent of the other impacted taxing jurisdictions should the County's request require a disbursement of the total PILOT payment which is not proportionate to the relative tax rates of the impacted taxing jurisdictions.

b. Includes an obligation to provide security for the decommissioning of the facilities constructed. The decommissioning obligation should be secured by a bond or letter of credit because most single purpose entities created to own winds farms have no assets other than those of a particular project.

Legislator Maxon wanted to make sure that the foregoing resolution is shared with the JCIDA in light of the recent UTEP they approved mirroring our former policy concerning alternative energy projects. Legislator Peck commended the IDA Board for passing the UTEP and taking the concerns expressed by everyone into consideration in doing so. He said it is a good balance between protecting the taxpayer and allowing a mechanism for development in the County. He inquired if there was anything new to report following the NYSAC conference, and asked if there was a plan of work for the shared services committee.

Administrator Hagemann advised that the shared services previously identified by the panel are moving forward in terms of discussions, but no specifics have been defined for long term. He said Jefferson County submitted a shared services plan to the State and if additional savings are realized outside the plan, they are not subject to reimbursement by the State.

Chairman Gray said the New York State Budget and many proposals in the budget were discussed at NYSAC, but he did not recommend advocating for certain proposals until the budget goes through the Senate and Assembly. He said the Governor has proposed such things as making the shared services panels permanent, and changes to indigent defense services.

Administrator Hagemann related that Veterans Service Director Pete Fazio is traveling to Oswego County to lend his services one day per week because their Veterans Service Agency Director position is vacant. Mr. Fazio has performed this service in Lewis County in the past, when the same position is vacant there. Mr. Hagemann explained that there are unique qualifications for this position that are required in order to process paperwork for those offices. Mr. Hagemann said this is a small shared service between counties that is worthy of note.

Legislator Jareo inquired if all towns are invited to the shared services meetings and said it would be a great opportunity to explore and talk about our largest shared service with the towns, dog control services. Mr. Hagemann advised that all towns and villages are invited to the shared services meetings and about 75% on average participate. Certain towns have expressed interest in a few areas (IT, Real Property) and those ideas will be explored with the towns that expressed interest as long as it is feasible. He assured that dog control has been brought up a few times. Chairman Gray suggested that since we are not under the gun this year to come up with a shared services plan, polling the towns and villages ahead of time to see what they may be interested in talking about would be advantageous as we can collect information and be prepared to talk about the issue at the meeting.

Legislator Johnson related that JCIDA Marketing Director Marshall Weir will be making a presentation at the Finance & Rules Committee meeting this month concerning IDA marketing strategies. Chairman Gray thanked Legislator Johnson for his representation on the IDA Board of the County's thoughts and concerns on the UTEP

Legislator Ferris inquired about the status of help for the Sheriff's Department in order to process pistol permits. Chairman Gray advised that one part time position has been approved already, the initial hire has since left and another person hired, an employee on light duty is also

helping out, but we have yet to hear back how the progress was changed from the time people were added. He said the Administrator has had several discussions with the Sheriff and Undersheriff about this and they are very aware of Board members' concerns. It has also been suggested to them that any down time the School Resource Officer (approved tonight) has should be devoted to pistol permit processing. He reminded legislators that as part of the normal process detectives do background checks associated with pistol permits and we have supplemented that with the part time position and the other efforts. He said the part time position is only approved through the end of 2018 at which time the Board can extend it.

There being no further business of the Board, on a motion by Legislator Ferris seconded by Legislator Doldo and unanimously carried, the meeting was adjourned at 6:25 p.m.
