A resolution is an item on which the entire Legislature votes. A resolution is generally brought before the Legislature by a Standing Committee. There are three Standing Committees: Finance & Rules, General Services, and Health & Human Services. Each Committee is composed of seven members, including a Chairperson appointed by the Chairperson of the Legislature. Each Committee has jurisdiction over various County Departments. Generally, the Committees meet once a month. (A meeting schedule of the Standing Committees can be obtained from the Clerk of the Legislature.) If a Department Head has an issue requiring Committee/Board action, it is presented to the Committee, usually in the form of a resolution. The Committee discusses and votes on the resolution. If approved, the resolution is brought before the full Legislature for vote. It may appear that some resolutions are voted on with little or no discussion, however, these resolutions have been discussed at length in Committee. Following approval of resolutions by the Legislature, the Clerk of the Legislature and/or Department Heads take appropriate action as dictated in the body of the resolution.
