**Director's Report** May 22, 2024

## **Community Services Office:**

Down one staff member on the EI side.

## County/State/ Federal Initiatives:

Crisis- Working with Pat Fralick and FDRHPO to work out details on RFP development for a two-county system. We have had a steering committee meeting, and more are planned. Working through contract logistics between counties. Things are in a bit of a holding pattern while County Admin makes a determination on whether we need to RFP the project management contract or if we can do the contract with FDRHPO as the sole source.

- We are in receipt of approx. \$560K in Regional Abatement Funding designated for 2024. I have received some inquiries from agencies who would like to request some of these funds for various projects. I think it might be best to rethink the earlier determination of using the funds to create two street outreach positions. I welcome all of your thoughts on the matter.
- \$100K Federal salary sharing is being distributed to clinics. One point of clarification is that the funds can only go to agencies licensed under OMH, OASAAS and OPWDD. They can also only go to entities currently contracted with the LGU.

# Local/Community Concerns/Issues:

- County Admin is turning over. New Deputy County Administrator was appointed last night. Bob H is retiring in June. Long time admin secretary retired a couple weeks ago. Things will be in transition for a while.
- We now have 4 Jefferson County residents in restoration services. Soon to be 5. As you may have heard or seen in the news, Jefferson County Legislators voted no to my request for \$940K for restoration services through September. Not sure how this will all shake out.

## **Suicide Prevention Coalition:**

- The Tabling Subcommittee has been attending events on a weekly basis, if not more.
- Will be creating a subcommittee for planning the annual Suicide Prevention Walk. This year's date is for Sunday, September 8th.
