Director's Report September 25, 2024

Community Services Office:

Fully staffed with no drama.

CS Budget was in on time. Budget meeting went well.

County/State/ Federal Initiatives:

Crisis- Jefferson County BOL has approved my proposal to do a sole source contract with FDRHPO to manage the design and build of our bi-county mobile crisis project. We will be coordinating with Lewis Co to establish an MOU so they can pay Jefferson as the lead county on the project.

We are in receipt of approx. \$560K in Regional Abatement Funding designated for 2024. I am currently working with the purchasing dept to issue an RFP in the hope that we will receive innovative proposals. All proposals that meet the requirements within the Opioid Settlement Funding Initiatives webpage are welcome and will be considered. Stay tuned for developments on the RFP.

Local Services Plan: N/A

Local/Community Concerns/Issues:

- Homelessness is once again a hot topic in Watertown. I attended a tour and leadership meeting in Ogdensburg two weeks ago and last week toured 3 different homeless shelters in Syracuse. My involvement continues to be in an advisory role. I continue to defer any media requests regarding homelessness to Jillian Redder.
- We continue to be in a holding pattern for restoration service payment. Community Services had received over \$500K in bills.
- This week I toured the Cannabis Depot on Murrock Circle. This is an initiative that establishes communication between the Alliance for Better Communities and our local smoke shops and dispensaries. SO far the owners that have been engaged have been extremely cordial and collaborative. We are providing CDC poisoning brochures and lock boxes to help keep cannabis and other potentially harmful substances out of reach of both youth and pets.

Suicide Prevention Coalition:

- Annual walk was very successful. We raised just over 4000 dollars this year.
- We held our first annual "Chalk the walk and have the talk" contest. The winner of the 100 dollar Vito's gift card was Watertown Child and Adolescent Wellness Clinic.
- We have released the 2024 JC Suicide Prevention Community Survey. which will run until September 30th. We will then use the results to compare to 2023 data.
- Our next big event will be in December we are hoping to do a gun safe raffle.
