THIRTY-FIRST ANNUAL REPORT OF THE JEFFRASON COUNTY BOARD OF BLECTIONS.

To Henorable Michael F. Walsh, Secretary of State, Albany, N. Y.: To The Honorable Board of Supervisors of the County of Jefferson:

In conformity with section 34 of the Election Law, the Board of Elections of the County of Jefferson herewith submits its report for the year 1942, and as a part of same, as required by law, will be found a statement of the number of voters enrolled with each party, the total registration of voters and the votes of the Primaries and General Election.

Only those who are directly connected with the Office of the Board of Elections realize how oneous and technical are its functions and duties in complying with the 342 sections of the Election Law and certain sections of the Executive and Panal Laws.

We have definite reasons to support our statements that the Jefferson County Board of Elections has functioned to the finest point in detail in that all vacancies for public offices and party positions have been filled; that qualified voters were given the right to exercise their franchise and that the vote of all electors at all elections were properly canvassed and that a true count given to each candidate.

This office, pursuant to law, canvassed the party enrollments of all voters, recorded the voter's politics in two Registration Books, and published the same. We have not heard of one error in this tremendous task.

OFFICIAL PRIMARISS, AUGUST 11th, 1942.

Pursuant to the drastic changes baused by the passage of the New York State Wer Ballot Commission, all primary dates were advanced five weeks.

More than 200 changes of enrollment caused by moving, becoming of age, gaining citizenship and errors in enrollment were recoded in two copies of the registers.

There were 161 petitions filed in this office for county and town officers, state committeemen, delegates and alternate delegates to state conventions, state committeemen and Democratic County Committeemen. All petitions had to be thoroughly checked and 201 notices of filing were mailed on postals to candidates.

For the Primeries 26144 Official and Sample Ballots were provided, which included three party ballots with 143 changes.

Immediately efter the primeries 247 Postal Determinations of election and nomination were mailed to the candidates for offices and party positions.

REGISTRATION

During the present year, six kinds of registration were conducted in this office, viz: Personal, Nonpersonal, Central, Military, Veterans and Federal Registration, under the Ramsey Act.

The emendments to the Election Law, passed by the 1942 Legislature, entailed much extra work in this office.

The time of Central Registration was extended from one to four months.

approximately 80 voters, centrally (personally) registered in this office. These voters enrolled and made applications for absentee ballots.

New York State voters who were in the armed or naval services of the United States and who were within the county were entitled to apply for registration and absentee domestic war ballots. The forms on which these applications were made were very inadequate in that no provision for the designation of the election district was listed. In this county 291 war ballot applications were received and 280 accepted.

Much trouble was experienced by this office in establishing the proper election district in which these soldiers were inducted into the service because of the lack of the designation of the election district on the application and also because the majority of these voters were voting for the first time.

It then became the duty of the Board of Elections to transfer the data appearing on each registration form, regular absentees and soldier absentees, to the three registers, to detach the applicant's signature and affix the same to the signature column of the register. This means that 1080 entries were listed in the registers before they were delivered to the various polling places for the regular registration days.

The wer bellot lew provided for a new and decidedly different absentee bellot. Much study and interpretation followed. We are pleased to announce that our war ballots were adopted by other counties and were highly commended.

GENERAL BLECTION

November 3rd, 1942.

About 200 applications for absentee ballots were received in this office, of which 174 were accepted. All applications were thoroughly checked and absentee ballots mailed to qualified electors.

For the General Risction of 1942, the foll ming ballots were provided:

- 1 for question.

On October 31st, Miss Grant, Clerk of this office, gave a school of instructions to 128 inspectors of the City of Metertown. We believe this instruction was productive of much good, because it was not necessary to recall one board of inspectors to this office to correct their returns.
