This annual report of the Board of Elections of Jefferson County for year ending December 31, 1987, is hereby submitted.

The organizational meeting of the Board for year 1987, was held on January 9, 1987, with William J.McClusky elected as President and Marsha J. Barton elected as Secretary.

The total budget for the Board of Elections was \$106,969.00 allocated to personnel costs, equipment costs and contractual expenses.

In 1987, Jefferson County had 39,370 registered voters who were eligible to cast ballots in the November General Election for State Ballot Proposals, Supreme Court Justices and local offices. 24,354 persons voted for 61.8% participation.

Due to mandates of the Election Law, persons who have moved or failed to vote in four years must re-register to vote. For this reason the number of voters eligible to vote for a general election and primary fluctuates. This office processed 3,537 registration forms.

1,175 persons were cancelled for failure to vote in four years.

Various community, political and special interest groups conduct annual voter registration drives within the county.

Area School District Administrators and Officials conduct a registration drive for high school students who will be eligible to vote by primary or election day. 1,315 registration forms were forwarded to schools in this county, of which 51% were returned.

Election Law mandates registration days to be scheduled after the deadline to receive mail-in registrations. Local Registration sites are located in municipal buildings, libraries, firehalls, schools and churches, which are staffed by Election Inspectors. In 1987, 303 persons were registered on local registration day.

State Election Law requires 4 election inspectors in each election district and further requires all new inspectors to be trained and tested when they are appointed and every three years thereafter.

An inspectors school was held in August 1987, covering duties, responsibilities, equipment, new laws and procedures and the 1987 elections.

Training sessions were held in September and October for Machine Custodians.

Pursuant to State Election Law, each Board of Elections must mail a notice to all voters before election each year to verify if the voter still resides at the residence from which he or she is registered. 38,977 verifications cards were sent in August 1987. 2,812 cards were returned by the postal authorities.

New York State Election Law requires those seeking public office to file petitions with a required number of signatures within a specified time. Petitions designating candidates for public office or political party position to be elected within Jefferson County are filed with the Board of Elections.

A total of 252 petitions were filed to designate candidates in 1987. 18 certificates of nomination were filed for candidates that were elected using a caucus system.

SUBJECT: Annual Report from Jefferson County Board of Elections

This annual report of the Board of Elections of Jefferson County for year ending December 31, 1986, is hereby submitted.

The organizational meeting of the Board of Elections for year 1986 was held on January 3, 1986, with Walton Aubertine elected as President and William J.McClusky elected as Secretary.

Central registration for voters opened on December 6, 1985, with 199 persons being registered centrally.

This office processed and approved 3397 applications for registration and enrollment by mail forms during 1986. 1,115 applications for registration and enrollment forms were forwarded to schools in Jefferson County for the registration of high school students who would be 18 years of age on election day. 662 forms were completed and returned. Additional forms were forwarded to town and village clerk's, public libraries, political parties and civic organizations.

The 1986 primary enrollment books were completed in February by county printing department containing 41,051 registered voters.

Enrollment tables were prepared after the publication of the primary books showing prior year registration by election district, total votes cast by election district for the November election and current enrollment by party and district.

Primary election was held on Tuesday, September 9, 1986, with voting hours from 12:00 Noon until 9:00 PM. The Democratic, Republican, Conservative and Liberal party primary was held at this time.

Primary election supplies were printed at a cost of \$1569.50

Local Registration was held on Saturday, October 11, 1986. 46 persons registered to vote in the City of Watertown and 287 persons registered in the towns, for a total of 333. Registration lists were tabulated and indicated the following:

The general election was held on Tuesday, November 4, 1986, with the following voted upon:

State Ballot Proposal (1), Governor and Lt. Governor, Comptroller, Attorney General, United States Senator, Justice of Supreme Court, Representative in Congress, State Senator, Member of Assembly, County Judge, Sheriff, City Judge - City of Watertown and town offices to fill vacancy in eleven towns.

A total of 41,400 persons were registered to vote in the November 1986 elections. 25040 persons voted or 60% participation.

General election ballots and machine supplies were printed at a cost of \$4438.00

The re-canvass of voting machines used in the general election was completed on November 7, 1986.

The school of instruction for inspectors was held on August 5 and 6, 1986, at Jefferson Community College.

Training sessions for machine custodians were held in September and October, 1986.

1024 voters were cancelled for failure to vote in the past four years.

41,224 address check cards were mailed to voters in Jefferson County, of this total 2370 cards were returned and undeliverable.

A computer system was installed at the board office in July 1986, with all registered voters being placed in the system.
