





I am guilty of clearing these machines and setting them up for voting on this proposition. I became aware of this mistake when I saw in the paper that Gregg might call for a recount of all of the voting machines.

I was under the impression that after the machines had once been recommissed by the Board of elections, they were free from further inspection. After reading about Gregg, I checked on the election law and learned what I should have known before, that said machines should not be tampered with for at least thirty days. I don't know what I can do now but if there is anything I can do, I am at your service.
