Education Law, Section 6301, paragraph 4, defines: resident. A person who has resided in the state for a period of at least one (1) year and in the county, city, town, intermediate school district of school district, as the case may be, for a period of at least six (6) months, both immediately preceding the date of such person's registration in a community college or, for the purposes of section 6305 of this chapter, his/her application for a Certificate of Residence.

\*\*In the event that a person qualified as above for state residence, but has been a resident of two (2) or more counties in the state during the six (6) months immediately preceding his/her application for a certificate of residence pursuant to section 6305 of this chapter, the charges to the counties of residence shall be allocated among the several counties proportional to the number of months, or major fraction thereof, of residence in each county.
